Dave W5OC emphasized the importance of retaining goodwill sponsorship for the WiFi by EV. Dave explained that the subsidy of this recurring charge is regularly scrutinized by the division and easily subject to termination if not pre-coordinated for support with the EV8 Branch Chief. Terry commented that he's tried to contact BC several times with no success.

Property Custodianship

It was proposed that David Fanelli, KB5PGY, receive the transfer of property custodianship of EV equipment (incl Flex Radios, Elecraft amp, Beko amp) currently under custodianship by EV8/Jack Wisbiski. This will preempt a likely request by EV.

ARISS access to W5RRR after hours

Discussion ensured about options to allow members (primarily AB4ME, since he is key JSCARC ARISS personnel) on site for ARISS passes afterhours. It was agreed that the practical approach is to request Security to keep the back gate open whenever an ARISS event was planned- e.g. keep gate open for ~3 hours to allow for pre-checkout, downlink event, and shutdown. Danielle KI5LQT agreed to discuss with Gilruth management (ACTION).

6. MISCELLANEOUS

John AB5SS reminded members and students that per decision at last meeting, all JSC interns now have free (no dues required) membership to the JSCARC. After licensed, they qualify for access to the shack.

During conversations of ARISS readiness and the new IC-9700 radio, John noted his action to add back the phonepatch configuration and ARISS related interfaces as needed for the IC-9700. (ACTION)

Dave W5OC elaborated on the recent meeting for the ARISS demo for the HQ AA of STEM, Mike Kincaid. Along with Mike, was Gamaliel (Dan) Cherry and Dynae Fullwood of the JSC STEM Offic /AD4. They conveyed their strong interest to work with the JSCARC to help bolster student outreach and their existing Texas STEM Grants, especially for the Sam Houston schools and a recent need to support scouts at the Strake Camp.
